4.1	NEW SOUTHERN DOWNS PLANNING SCHEME – EMU SWAMP DAM	MAYOR HAMILTON DECLARED A DECLARABLE CONFLICT OF INTEREST IN THIS MATTER (AS DEFINED IN SECTION 150EQ(4)(A) OF THE LOCAL GOVERNMENT ACT 2009) AS SHE HAS ADVOCATED THAT COUNCIL SHOULD NOT BE INVOLVED IN THE GRANITE BELT IRRIGATION PROJECT (EMU SWAMP DAM) BECAUSE COUNCIL AND RATEPAYERS WERE EXPOSED TO SIGNIFICANT RISK OF COST OVERRUNS IN THE PROJECT, AND BECAUSE COUNCIL WAS NOT GETTING THE FULL VALUE OF THE TOWN WATER ALLOCATION IN THE DEAL THAT WAS DONE WITH THE PROJECT PROPONENT. WHILE SHE BELIEVES SHE CAN MAKE DECISIONS ON WATER SECURITY FOR THE REGION IN THE PUBLIC INTEREST AND PERFORM HER COUNCILLOR RESPONSIBILITIES AND SERVE THE PUBLIC INTEREST OF THE REGION, THERE MAY BE A PERCEPTION IN THE COMMUNITY THAT SHE HAS A CONFLICT OF INTEREST IN MATTERS RELATING TO EMU SWAMP DAM. THE PROJECT IS NOW ON HOLD, THE PROPONENT IS IN LIQUIDATION AND IN ANY FUTURE ITERATION OF THE PROJECT THOSE PARTICULAR ISSUES MAY NOT BE RELEVANT. FOR FULL TRANSPARENCY SHE HAS NOT BEEN ON ANY BOARDS OR COMMITTEES RELATING TO EMU SWAMP DAM. NONE OF HER FORMER CLIENTS ARE POTENTIAL INVESTORS IN THE DAM. NONE OF HER FORMER



ARE POTENTIAL INVESTORS IN THE DAM. SHE DOES NOT HAVE AN INTEREST, WHETHER IN HER OWN NAME, THROUGH A COMPANY OR A TRUST, IN LAND IN THE PROJECT AREA.

ALTHOUGH MAYOR HAMILTON HAS RAISED A DECLARABLE CONFLICT OF INTEREST. SHE DOES NOT BELIEVE A REASONABLE PERSON COULD HAVE A PERCEPTION OF BIAS BECAUSE OF HER CONFLICT. THEREFORE, MAYOR HAMILTON WILL CHOOSE TO REMAIN IN THE MEETING AND NOT VOTE ON THIS MATTER, HOWEVER SHE WILL RESPECT THE DECISION OF THE MEETING ON WHETHER SHE CAN REMAIN AND PARTICIPATE. FOLLOWING A RESOLUTION FROM COUNCIL, MAYOR **HAMILTON** PARTICIPATED IN THE DISCUSSION BUT NOT IN THE VOTE ON THE MATTER.
