4.1 Proposal to Install Disabled Car Parks at Rear of Warwick Town Hall

Recommendation

THAT Council resolve to construct 3 disabled car parks in the area occupied by the former public toilets at the rear of the Warwick Town Hall.

Report

Council approved the decommissioning of the public toilets behind the Warwick Town Hall. The process of removal was extended due to an appeal to the Heritage Council that was unsuccessful. As part of the resolution at the General Council Meeting on 24 May 2017, Council resolved to replace the toilets with RV parking.

The capacity to accommodate RV parking was seen as important as it was suggested that the relocation of the Visitor Information Centre to the Warwick Town Hall would mean that visitors to Warwick would not be able to easily access the Visitor Information Centre. The suggested drop in numbers to the Visitor Information Centre has not occurred, in fact the number of people presenting at the Visitor Information Centre has increased significantly.

Additionally, there have been few complaints about RV visitors not being able to access the Visitor Information Centre. It would appear that the spaces provided for RVs and caravans in Fitzroy and Palmerin Street are being well utilized.

Therefore, given the absence of demonstrated demand for the installation of specific space for these vehicles in close proximity of the Visitor Information Centre, it is recommended that 3 disabled carparks be installed in the area of the former public toilets. If the creation of 3 disabled car park spaces at the decommissioned toilet site were considered, then this option will have an overall net increase of 3 parking spaces.

In relation to access to public toilets, it is noted that during business hours toilets can be accessed within the Warwick Town Hall, at the Warwick Art Gallery and the Warwick Library. The Grafton Street toilets are open 24 hours per day.

Budget Implications

The cost of line marking will not require further budget allocation as this expense will be funded from the existing operational budget under Local Road Maintenance.

Community Engagement

Extensive community consultation was undertaken in relation to the removal of the toilets. In April 2017, Council resolved to seek public feedback on the proposed decommissioning of the facility. In response, Council received thirty-nine (39) submissions, with 87% of the respondents suggesting that the facility should remain.
